## Chung Yuan Christian University, Credit Exemption Regulations for General Education

Article 1. These regulations are formulated in accordance with Article 7 of the School Constitution of Chung Yuan Christian University and the Key Points for Reviewing Student Credit Exemptions at Chung Yuan Christian University.

Article 2. The following students are eligible to apply for credit exemption:

- I. Transferring undergraduate students, new undergraduate students who have retaken the entrance examination or are reapplying for admission, university dropouts, students in credit classes, graduates of vocational schools or those who are allowed by laws and regulations to study for credits before passing the examination and obtaining a degree.
- II. Master's and doctoral students who have completed one of the General Education courses at the University with a score of 70 points or above, and whose credits are not included in the minimum score for graduation and hold a certificate as proof.

Article 3. The principles of credit exemptions for undergraduate students are as follows:

I. English and English Listening courses:

The credits can be exempted if the course name indicated on the transcript is the same as or similar to the course name of "English" or "English Listening" at the school and the course is mandatory. For subjects that cannot be recognized, the student should provide proof of course content from the original school or department and the credits can be exempted after being reviewed and approved by the Language Center. For graduates of five-year vocational colleges, the eligible courses are limited to mandatory courses such as "English" or "English Listening and Speaking" taken after their fourth year of vocational college with passing grades.

- II. Other General Education courses:
  - (I) If the transcript indicates that it is a General Education course, or the original

school provides proof that it is a General Education course and the school has indeed offered the same or similar subjects, then the credits may be exempted.

- (II) For subjects that cannot be recognized, students can provide proof of course content from their original school or department. The credits may be exempted after the department sends the document to the General Education Center for review.
- (III) Courses that have not been offered by the school are not eligible for credit exemption and no credit exemption recourse is allowed even if such courses are offered from the following semester onward.
- (IV) Mandatory specialized subjects and elective subjects cannot be used to exempt general education course credits.
- (V) Continuous courses of one credit each in the first and second semesters of the entire academic year are recognized as two credits.
- (VI) Graduates of five-year vocational colleges who have completed courses after the fourth year of vocational education are eligible for credit exemption.

Article 4. The handling of exemption of different credits for undergraduate students is as follows:

- I. Using more credits to exempt less: After the exemption, the credit will be registered with that of the courses offered by the school.
- II. Using less credits to exempt more: Not allowed. For a zero credit "English Listening and Speaking" course from a prior university, if proof can be provided that there are two class hours per week and the class is conducted in a classroom and with English as the practical language, then a credit exemption is allowed.

Article 5. The upper limit of credit exemption for undergraduate students is as follows:

- I. Basic knowledge and skill courses:
  - (I) Four credits can be exempted for English.
  - (II) Two credits can be exempted for English Listening and Speaking.
- II. Basic courses:
  - Two credits can be exempted for each of the courses, "Religious Belief and Spirituality" and "Meaning of Life and Value Judgment" in
  - (II) Two credits can be exempted for each of the courses "Civic Literacy and Social Care" and "Historical Thinking and Multiculturalism" in the Humanities Department.
  - (III) Two credits can be exempted for each of the courses, "Computational Thinking and Programming" and "Natural Science and Artificial Intelligence" and related courses on contemporary scientific issues in the Material category.

- (IV) Two credits can be exempted for each of the courses, "Emotion and Aesthetics" and "Communication and Expression" in.
- III. Extended courses: Up to 10 credits can be exempted (the course requirements of the University's General Education curriculum shall be met)
- IV. For those who did not complete their studies at the University but later are accepted back, the General Education courses already completed are eligible for credit exemption according to regulations.
- Article 6. Students in master's and doctoral programs who meet the requirements of Article 2 of the Regulations may have up to two credits exempted.
- Article 7. The Regulations shall be approved by the Academic Affairs Meeting and submitted to the President for publication and implementation. The same procedure applies to its amendments.
